A. Ulrickson highlights some projects FCSS is working on.

- 4. Report from council L. Hansen

L. Hansen asks for feedback regarding the pilot project of lowering speed limits in Southfork to 40 km/hr. First reading was passed to lower the speed limit to 40 km/hr in all residential areas of Leduc. Discussion. Edmonton has created pop-up dog parks. Council is considering doing the same in Bridgeport and Suntree. Temporary fencing would be set up in these areas for six to eight months. Council will look at implementing it in 2024.

Arts Foundry presented to council. L. Hansen reports the Arts Foundry programming and capacity percentages are exceptionally good. Arts Foundry provides free programming for the community every Tuesday.

- T. Tijani asks about zoning for the new school across from Woodhaven community. Discussion. Configuring is in progress.
- 5. Round Robin
- T. Turner- there are opportunities for the city's annual awards. Candidate proposals are due April 30<sup>th</sup>. The category for Arts and Influencers only has one candidate nominated and she requests that if the trustees know of a potential candidate to please nominate them.
- C. Frybort- thirteen new outreach patrons have joined the program. A library patron from Lifestyles had asked for someone to come to Lifestyles to speak about the outreach program. C. Frybort expects another jump in clients.

The library is partnering with Leduc Transit. Leduc Transit will be taking seniors on tours to different spots in Leduc. They will be visiting the library sometime in May, where she will give the seniors program information and a tour of the facility.

International Youth Week occurs in August. C. Frybort will meet with the Arts Foundry director to partner on a project for the event.

- C. Frybort explains some of the features on the new library website.
- J. Storeshaw asks about the Coronation Tea program. C. Frybort replies that the kits will be available for pick-up starting April; 26<sup>th</sup>. J. Storeshaw also asks about the new library sign. C. Frybort is working on three quotes.
- C. Frybort reminds the board that at the May meeting, Dr. Margaret Law will be working with them on Philosophy of Compensation.
- C. Frybort is hoping the financial statements will be ready to approve at the May meeting. She will bring in a meal for the board.
